Anyone new to carbon farming and the Australian Carbon Credit Unit (ACCU) Scheme should seek professional advice to determine project feasibility, planning and design, and for assistance with the technical and regulatory requirements of registering the project. There are also opportunities from insetting within the supply chain using carbon credits and the emerging biodiversity credit markets.

The advice depends on the type of project, the landowner's knowledge and experience, property size, location, and business structure. Services range from project planning, technical soil analysis, project management, site mapping to plant species selection.

The Department of Primary Industries and Regional Development (DPIRD) has compiled this Service Provider Directory to connect landholders with advisors.

Carbon Project Development & Management

- Are they a signatory to the **Australian Carbon Industry Code of Conduct**?

The Carbon Market Institute administers the Australian Carbon Industry Code of Conduct. A list of **current signatories** is available.

- Anyone giving financial advice (i.e. ACCU price, trading options) must hold a current **Australian Financial Services Licence** (AFSL).

The Australian Securities and Investments Commission is responsible for administering the AFSL regime and keeps a searchable **professional register** of all AFSL holders.

Natural Resource Management, Land Care and Grower Groups

Soil Technicians and Laboratories

- Is the soil technician experienced in collection and handling of samples for organic carbon and bulk density analysis?
- Is the spectrometer technician experienced in the Clean Energy Regulator's requirements for the spectrographic device settings and the sampling process and analysis?
- Does the laboratory have the relevant Australasian Soil and Plant Analysis Council (ASPAC) certification and National Association of Testing Authorities (NATA) accreditation?

The **soil carbon method** requires Australasian Soil and Plant Analysis Council (ASPAC) certification for Total Carbon method 6B2 and Total Organic Carbon method 6B3, and NATA accreditation for organic carbon, bulk density and moisture analysis. **ASPAC** and **NATA** list laboratory status on their websites.
