1. Definitions

4G & 5G mean the fourth-generation and fifth-generation mobile telecommunications service respectively.

Department means the Department of Primary Industries and Regional Development.

Guidelines mean the Surf Beaches Mobile Coverage Grants Program Round 2 Guidelines dated 7 August 2024.

FAA means Funding Assistance Agreement to be executed between the State and the successful Proponent(s).

Minister means the Government of Western Australia's Minister for Regional Development.

Network means the network infrastructure and related support systems that will be built as part of a Project.

Panel means an assessment panel established to evaluate all the Proposals against the Eligibility and Assessable Criteria detailed in Sections 3.2.1 and 3.3.1.

Parks mean Conservation/National/Regional and Nature Reserve defined under the Conservation and Land Management Act 1984.

Program means the Western Australian Government's Surf Beaches Mobile Coverage Grants Program Round 2.

Project means a Proposal that has been accepted by the Western Australian Government for funding under this Program. It includes network infrastructure and related support systems that will be development by its Proponent.

Proponent means the entity or consortium that has submitted a Proposal to the Western Australian Government for funding consideration for this Program.

Proposal means the documentation submitted by a Proponent to the State for funding consideration under the Program. The documentation includes network infrastructure and related support systems and could be funded by the Western Australian Government.

Site(s) mean the beaches and locations of significance in regional Western Australia as depicted in **Attachments 1** and **2**.

SBR1 means Surf Beaches Mobile Coverage Grants Program Round 1.

SBR2 means Surf Beaches Mobile Coverage Grants Program Round 2.

State means the Government of Western Australia.

2. Background

The Surf Beaches Mobile Coverage Grants Program is a grants program, funding the delivery of telecommunications infrastructure to regional beaches without or poor mobile coverage. These beaches are heavily frequented by tourists, the local community and visitors for surfing, camping, fishing, picnics, snorkelling and other recreational activities.

Under SBR1, the Western Australian Government awarded \$1.1 million to Powertec Telecommunications Pty Ltd to deliver mobile repeaters at 20 popular surf beaches primarily to enhance the safety of the community and visitors at popular beaches from the Kimberley to the Goldfields-Esperance regions.

Following the funding awarded under SBR1, the Department continued to work towards identifying further popular beaches across regional and remote locations throughout the State. SBR1 received positive reception from stakeholders including Surfing WA, the Department of Biodiversity, Conservation and Attractions (DBCA), the Regional Development Commissions, Shires and the general public.

Stakeholder engagements, and ground truthing efforts undertaken by the Department has led to the identification of a further 35 sites that could benefit from enhancements in mobile connectivity. Details of the proposed sites are shown in **Attachments 1** and **2**.

3. Surf Beaches Mobile Coverage Grants Program Round 2

Funding of up to **\$2 million** is available from the State Agricultural Telecommunications Infrastructure Fund for the Program.

The Program will prioritise proposals that provide the largest coverage for the Sites with fit-for-purpose and innovative digital technologies.

Noting, where Site(s) may be located within parks, proposals should provide the least amount of infrastructure, preferably leveraging on existing developed or disturbed Sites such as car parks, beach toilet/shower blocks, existing mobile towers, and other infrastructure, to minimise the impacts of visual amenities.

Augmentation and upgrade of existing mobile towers not within the Site(s) coordinates is acceptable if proposals address improved mobile coverage for the Site(s).

It is the responsibility of the proponent to obtain the required and relevant access, approvals and permits for the proposed Site(s).

Proponents are advised to engage with land management authorities such as DBCA, Traditional Owners and/or Local Government Authorities as early as possible as approvals may be complex and can take considerable time. In this regard, the Department can assist with the provision of information and contact details of key stakeholders.

3.1 Program Stages

The Program will be delivered in four stages. From the proponent's perspective, the stages will progress as shown in Table 1 below:

Table 1 - Program Stages

Program Development

- · Proponents to develop Proposals for the WA Government
- The State will repond to queries from the prospective Proponents
- Proponents to submit their proposals to the State by the Closing Date

Assessment

- The State will assess all qualifying Proposals received
- The State will shortlist and announce selected Proposals

Project Development

- · The State will enter into funding agreements with succesful proponents
- Proponents to construct and deliver projects in accordance with funding agreement
- The State will disburse funds in accordance with the funding agreement

Operation

- The proponents agree to operate the infrastructure for an agreed period as specified in the funding agreement
- The State will seek information from the proponents as agreed in the funding agreement to assess the Program's outcome

Each proposal must demonstrate its eligibility against all the criteria listed in Section 3.2.1. Failure to demonstrate against any eligibility criteria will result in its disqualification and thus halts its progression to the assessment stage detailed in Section 3.3.

An assessment panel will evaluate all the proposals against the eligibility and assessable criteria detailed in Sections 3.2.1 and 3.3.1.

3.2 The Program Development Stage

The Department recommends that Proponents engage closely with stakeholders while preparing a Proposal. A Proposal can have multiple Proponents as long as its key Proponent is a <u>Licensed Carrier</u> under the <u>Telecommunications Act 1997 (Cth)</u>. A Licensed Carrier is authorised under this Act to provide carriage services to the public. However, Proponents without a Carrier License will be considered for the Cel-Fi repeater proposals only.

Applications from Proponent's holding only a *Nominated Carrier Declaration* will <u>not</u> be accepted.

Proposals must detail how the project will provide improved mobile coverage to the Site(s), including providing the Department with detailed solution and specifications to the proposed coverage maps.

As the land terrain may pose challenges to cover the entire stretch for the Site(s), Proposals shall address the mobile connectivity issues to provide the largest possible coverage.

3.2.1 Eligibility Criteria

Proposals must satisfy all Eligibility Criteria to qualify for funding.

The State is looking to award grants for the site(s) and will evaluate the submissions under these following Eligibility Criteria.

3.2.2 What the WA Government will fund

State funding under the Program will cover capital costs for improving mobile connectivity to the Site(s). Capital costs may include infrastructure, engineering design, site acquisition, power/solar/battery connection, construction, equipment, regulatory approval costs and related one-off expenses, including costs for labour.

3.2.3 What the WA Government will not fund

State funding cannot be used for:

- Any network components for Internet of Things (IoT) devices.
- Ongoing operational maintenance, repairs or upgrades of the Network infrastructure.
- Feasibility studies, cost benefit analysis, impact studies, marketing plans, environmental assessments and research or compliance.
- Project management, operations or staff-related expenses, except during the construction stage.
- Any costs incurred in connection with preparing and submitting an application for funding under the Program, providing or considering additional information, or engaging in discussions/negotiations sought by the Panel or undertaking any discussions or negotiations with the Department.
- Retrospective funding, where the projects have been completed or commenced construction prior to the date of notification of a successful application for funding under the Program.

3.2.4 Co-contributions

Due to the location of Site(s) and the need to improve the safety of beach users, funding co-contribution is not mandatory. However, the Department would welcome any Proponent and/or third party financial and in-kind co-contributions to the Program.

Examples of in-kind contributions could include but not limited to:

- a commitment for complementary access to existing infrastructure,
- identifying a suitable site for infrastructure placement,
- civil works required to access a site,
- assistance with connecting power,
- facilitating access to existing infrastructure.

Where a value is assigned to in-kind co-contributions, the methodology for the valuation must be detailed in the Proposal.

The Department may verify Proponent Proposal cost claims independently and contact third parties detailed in the Proposal.

Proponents are responsible for securing all third-party commitments and covering any shortfalls if third party contributions do not proceed.

3.2.5 How to apply

3.2.6 Closing Date

The Closing Date for submission of Proposals is 8 November 2024.

Proposals will not be accepted beyond the Closing Date.

3.3 The Assessment Stage

Proposals appraised to have met all Eligibility Criteria detailed in Section 3.2.1 will progress with an assessment based on the Assessable Criteria as detailed in Section 3.3.1.

Assessments will be made regarding the proposed technical specifications, technical capability, experience, value for money and risk profiles of all eligible proposals and their proponents.

Eligible proposals will be assessed by a Panel that will consider the relative merits of each proposal and make recommendations to the Department. The panel may, at its absolute discretion, request additional information to assist its evaluation of a proposal. The Minister will provide final approval and may choose, in his absolute discretion, to reject, without liability, any or all proposals submitted.

Unsuccessful proponents will be able to seek feedback from the Department on their proposal, however, the decision of the Minister is final and cannot be appealed.

3.3.1 Assessable Criteria

Proposals will be assessed according to these Assessable Criteria, which generally reflect the Eligibility Criteria detailed in Section 3.2.1.

3.4 The Project Development Stage

State grants funding will be provided through a FAA that the Department will negotiate with each successful Proponent on behalf of the State.

Proponents are required to demonstrate progress in delivering their projects in return for the State's progressive disbursement of grants.

3.4.1 Financial Assistance Agreement

The Proponent will be required to execute a FAA with the State to deliver the Project.

Where the Department considers appropriate, a phased approach may be adopted for payment of grant based on agreed milestones. Payments of milestones will be negotiated with successful Proponents.

The FAA will include, amongst other things, obligations in relation to approvals, reporting, acquittal and audit requirements.

A copy of a <u>standard FAA</u> is available for reference to the terms and conditions under which the State is prepared to contract with successful Proponent. The Department's standard policy is that the Operative part of the FAA is <u>NOT TO BE AMENDED</u>, as its subsequent schedules are sufficient to reflect relevant details of the Proposal or Project without necessitating changes to existing provisions.

The FAA must be signed by both the Proponent and the State before the funded activities of the Project commence and grant funding becomes available.

If the FAA cannot be successfully negotiated and agreed between the parties within a reasonable period of time, the Department may, in its absolute discretion, withdraw from negotiations.

For the avoidance of doubt, no legal obligation of any kind will be owed to the Proponent, nor will the Department be liable for any direct or indirect loss suffered by the Proponent as a consequence of a decision to withdraw.

3.4.2 Approvals, Permits and Regulations

The Proponent is responsible for acquiring all relevant approvals, permits and regulations and complying with all legislative and regulatory requirements while developing the Project and operating the Network.

Approvals will be required to locate infrastructure in parks under the *Conservation and Land Management Act 1984 (where applicable)* and no legal or other obligation shall rise between a proponent and the State unless and until all necessary approvals and consents have been obtained, including Ministerial approval. There is no obligation on the State to proceed with any Proposal should these approvals not be obtained.

The Department is unable to provide advice or recommendations other than for matters under its administration. Please refer to the <u>Department's Annual Report</u> for further information.

3.5 The Operation Stage

3.5.1 Requirement to operate and maintain

Proponents will be required to manage, operate and maintain all infrastructure and equipment, constructed and installed for a period of five (5) years.

3.5.2 Statistics

Proponents will be asked to provide information at intervals to be specified in the FAA of the funded Network on metrics as such the number of connections, data throughput and average contention rates to inform the Department's evaluation and review processes.

3.5.3 Freedom of Information Act

Please note that the Department is subject to the <u>Freedom of Information Act 1992</u> (WA), which provides a general right to access records held by State agencies and Local Government Authorities.
